## **Dine More, Save More Cash Rebate Campaign - Terms & Conditions**

### **Eligibility & Promotion Mechanics**

1. The "Dine More, Save More" Cash Rebate Campaign ("Promotion") is valid from **20 May 2026 to 30 June 2026** (both dates inclusive, hereinafter referred to as the "Promotion Period").
2. The Promotion is valid only for cardmembers of the **DCS Ultimate Platinum Mastercard, DCS Flex Visa Platinum Card, and DCS Ultimate Platinum UnionPay Card** (each an "Eligible Card").
3. The Promotion is open to Principal Cardmembers of Eligible Card ("Eligible Cardmember(s)") who successfully opt in via the [Registration Form](#). Submissions with incorrect, incomplete, or invalid details will be deemed ineligible.
4. Limited to the first **1,000** Eligible Cardmembers who successfully register and meet the cumulative minimum spend of **S\$100 or S\$200** on the Qualifying Dining Categories during the Promotion Period, or until the campaign cap is reached, whichever occurs first.
5. Spending is accumulated cumulatively across the Promotion Period. Minimum cumulative spend of S\$100 qualifies for S\$8 cash rebate; minimum cumulative spend of S\$200 qualifies for S\$15 cash rebate.
6. The maximum cash rebate per Eligible Cardmember is S\$15 for the Promotion Period.
7. Eligible Cardmembers must opt-in before making qualifying transactions. Transactions made prior to opt-in will not be counted.
8. Eligible Cardmembers whose current mobile number differs from their DCS Registered Mobile Number must update their records with DCS Card Centre ("DCSCC") prior to registration. Eligible Cardmembers who register with a mobile number that does not match DCSCC's internal records will be automatically disqualified.
9. Full payment must be made with an Eligible Card to qualify for the Promotion.
10. Any transaction reversals, refunds, or cancellations posted during the Promotion Period will be deducted from the cumulative qualifying spend and may impact the Eligible Cardmember's eligibility.



11. DCS reserves the right to withhold, cancel or clawback rewards in cases of failed or reversed transactions, suspected misuse or policy violations, including after the Promotion Period has ended.
12. Qualifying transaction is strictly limited to transactions made under the following Merchant Category Codes (MCC) ("Qualifying Dining Categories"):
  1. **MCC 5812:** Eating Places and Restaurants
  2. **MCC 5814:** Fast Food Restaurants & Online Delivery (e.g., GrabFood, Foodpanda)
  3. *Note: MCCs are assigned by the respective acquiring banks. DCSCC is not responsible for any misclassification of merchant codes by external vendors.*
13. By participating in this Promotion, Eligible Cardmembers agree to be bound by these Terms and Conditions.
14. Only Principal Cardmembers of Eligible Cards are eligible to participate. Spend incurred on Supplementary Cards will not be combined and credited to the Principal Cardmember's account for cumulative spend tracking.
15. Each Principal Cardmember may register only **one (1) Eligible Card** for this Promotion, regardless of the number of Eligible Cards held.

### Reward Fulfillment

1. Cash Rebates are limited to the **first 1,000 Eligible Cardmembers** who successfully register and fulfill the spending criteria on a first-come, first-served basis.
2. Cash Rebates will be credited to the Eligible Cardmember's main account within **14 business working days** upon reaching the cumulative minimum spend milestone of S\$100 or S\$200 through qualifying transactions, or after the Promotion Period ends on 30 June 2026, no later than 30 July 2026.
3. The Cash Rebate is strictly non-transferable and cannot be exchanged for credit, cash, or other goods and services.
