

## Go Global Cashback Campaign - Terms & Conditions

### Eligibility & Promotion Mechanics

1. The "Go Global Cashback" Campaign ("**Promotion**") is valid from **14 July 2026 to 31 August 2026** (both dates inclusive, hereinafter referred to as the "Promotion Period").
2. Receive an extra **4% Cash Rebate** on top of your base cashback for all eligible foreign currency spend ("**Qualifying Transactions**").
3. This Promotion is open to Principal Cardmembers of the **DCS Ultimate Platinum Mastercard, DCS Flex Visa Platinum Card, and DCS Ultimate Platinum UnionPay Card** ("Eligible Cards").
4. To participate, the Principal Cardmembers of Eligible Cards ("Eligible Cardmembers") must opt in via SMS: FXBACK [last 4 card digits] to 83184448. SMS must be sent before the campaign ends on 31 August 2026, and before making any Qualifying Transactions. Qualifying Transactions made prior to opt-in will not be counted.
5. Both new and existing Eligible Cardmembers must opt-in by submitting their details via SMS during the Promotion Period. An opt-in SMS with incorrect, incomplete, or invalid details will be deemed ineligible.
6. Limited to the **first 500** Eligible Cardmembers who achieved the minimum cumulative Qualifying Transactions of S\$600 during the Promotion Period, capped at \$50 per Eligible Cardmember.
7. By participating in this Promotion, the Eligible Cardmembers agree to be bound by these terms and conditions.
8. Foreign currency refers to any lawful currency, other than Singapore Dollars.
9. For foreign currency spend to be eligible, the transaction made at the overseas point of sale must be charged in foreign currency. If the payment has been converted to Singapore Dollars by the overseas merchant at the point of sale, the transaction will not be eligible for the Promotion.
10. Only transactions posted during the Promotion Period will be considered for the eligibility of the Promotion.
11. Any transaction reversals, refunds or cancellations posted during the Promotion Period will be deducted from the cumulative qualifying spend amount and may impact eligibility for the Promotion.

12. DCS reserves the right to withhold, cancel or clawback rewards in cases of failed or reversed transactions, suspected misuse or policy violations, including after the Promotion Period has ended.
13. Only Principal Cardmembers of Eligible Card are eligible to participate. Spend incurred on Supplementary Cards will not be combined and credited to the Principal Cardmember's account for cumulative spend tracking.
14. Eligible Cardmembers whose current mobile number is different from the DCS Registered Mobile Number are required to first update their mobile number with DCSCC before registering for the Promotion. Eligible Cardmembers would not be eligible to participate should they register for the Promotion with a mobile number different from DCS Registered Mobile Number.

### **Reward Fulfilment**

1. Cashback is limited to the first 500 Eligible Cardmembers who successfully fulfill the spending criteria on a first-come, first-served basis.
2. Cashback will be credited to your DCS account after the Promotion Period ends on 31 August 2026, not later than 30 September 2026.
3. The Cashback will be computed and rounded down to the nearest two decimal places.
4. The Cashback is strictly non-transferable and cannot be exchanged for credit, cash, or other goods and services.

### **General**

1. To receive the reward, the Eligible Cardmember's DCS account must be in good standing, active, and conducted in a proper and satisfactory manner as solely determined by DCSCC at the time of fulfillment.
2. These terms and conditions are to be read together with the DCS Cardmembers Agreement and any other specific product terms applicable to the Promotion. In the event of any inconsistency, these terms shall prevail only to the extent of the inconsistency.
3. DCSCC reserves the right to amend, change, or vary these terms and conditions, or withdraw this Promotion at any time without prior notice or assigning any reason. In the event of any dispute, the decision of DCSCC shall be final, binding, and conclusive.
